

INFORMATION

Pursuant to and for the purposes of Article 13 of European Regulation no. 2016/679 (hereinafter the Regulation), we provide you with the following information regarding the processing of personal data that you provide us with in order to send you newsletters from the Company.

1. Data controller

The Data Controller is Centro tessile Cotoniero e Abbigliamento SpA (C.F. and VAT number 01724710122), with registered office in Busto Arsizio - VA, Piazza Sant'Anna,2, telephone 0331.696711, fax 0331.680056 e-mail address info@centrocot.it address PEC centrocot@certimprese.it (hereinafter the "Company").

2. Data Protection Officer

The Data Protection Officer appointed by the Company may be contacted by sending an e-mail to dpo@centrocot.it (hereinafter "DPO").

3. Personal data

Personal data means any information that concerns and is referable to you.

Specifically, the processing will concern the following data: name, surname, e-mail address (hereinafter the "Data").

4. Purposes of the processing

Your data will be used to send newsletters containing articles, news, information regarding the activities and initiatives of our Company.

5. Legal basis of the treatment

The processing of your data for the purposes indicated in point 4) above finds its legal basis in the consent given by you.

6. Methods of processing

Within the scope of the purposes indicated in point 4) above, the processing of your data will be carried out by electronic means, in compliance with the regulatory provisions on the processing of personal data, adopting the appropriate security measures.

The processing of your data will be managed by specially trained and instructed personnel, precisely to ensure adequate security and confidentiality, as well as to avoid the risk of loss and/or destruction and access by unauthorized parties.

7. Communication and dissemination of data

Within the limits strictly pertinent to the purposes indicated in point 4) above, your data may be communicated to specifically designated internal subjects within Centrocot who carry out activities related and instrumental to the evaluation of your professional profile.

In case of necessity, for activities related to the management and maintenance of computer systems, the

Data can be treated by the company specifically appointed as Data Processor.

The list of persons appointed as Data Processors is available at the Company's registered office.

8. Data retention period

Your Data will be stored until you revoke your consent, including by unsubscribing, in accordance with the procedures indicated in the successful paragraph 9.

9. Rights of the data subject

With reference to your data, you have the right to ask the Company with the methods indicated in the Regulations and without prejudice to the provisions and limitations of Legislative Decree no. 196/2003 (Part I - Title I - Chapter III):

- access, in the cases provided for (art.15);
- correction of inaccurate Data and integration of incomplete Data (art. 16);
- the deletion of Data for the reasons provided for (art. 17), such as when they are no longer necessary with respect to the purposes indicated above or are not processed in compliance with the Regulations;
- the limitation of processing for the cases provided for (art. 18), such as when the accuracy of the Data is contested and its correctness must be verified;
- the portability, i.e. the right to receive, in the cases provided for (art. 20), in a structured format of common use and readable by automatic device the Data and to transmit said Data to another data controller;
- the opposition to the processing, in the cases provided for (art. 21).

You also have the right to revoke your consent at any time without prejudice to the lawfulness of the processing carried out before the revocation.

All the rights listed above may be exercised by you by sending a communication to the Company by e-mail to privacy@centrocot.it or by registered letter to Busto Arsizio (VA), Piazza Sant'Anna 2, to the attention of the Privacy Contact.

In addition, to stop receiving the newsletter you can click on "unsubscribe" / "unsubscribe" at the bottom of each communication sent by email.

10. Complaint

If you believe that the processing of your data violates the provisions contained in the Regulation, you have the right to lodge a complaint with the Guarantor for the protection of personal data in accordance with the provisions of art. 77 of the Regulation itself.

11. Nature of the provision of Data

The provision of your data is a necessary requirement to allow the sending of Company newsletters containing articles, news, information regarding the activities and initiatives of our Company.

Failure to provide even a part of your data will make it objectively impossible to proceed with the sending.

12. Transfer of Data Abroad

Your Data is stored at the headquarters of Centrocot, on servers located in the European Union. The Company also uses cloud services provided by companies from third countries recognized as adequate in terms of security by the Commission pursuant to art. 45.3 of the Regulation.
